Amman Civil Airport New Identity



As part of the complete upgrade plan for Amman Civil Airport, Jordan Airports Company(JAC) has developed a new identity for the airport; which includes a new logo design that reflects the nature of the airport as a city airport for the capital of Jordan, and is derived from the identity of Jordan Airports Company.

Moreover, to facilitate the communications with the passengers and investors at the airport, a social media profiles were created and will be upgraded regularely to provide an accurate and on time information. Additionally, JAC is in the process of developing a new website for amman civil airport and mobile application and other E-services.

Cargo Inspection Center



The center is being managed by Jordan Airports Company (JAC), will be able to inspect cargo shipped through QAIA in a much safer and faster manner than using traditional X-ray machines.

Duty Free Area alongside QAIA

Free Zones Company signed an agreement with JAC to rent 300 Dunums of JAC's project around Queen Alia International Airport; to develop a multi-use free zone area (industrial, commercial and services). The area will attract and fulfill the requirements of the investors in these diverse sectors to serve the national economy and the business development plans of the company at Jordan's main gateway QAIA in line with logistics offering in this area.

The total cost to develop this area is approximately 3 million Jordanian Dinars, taking into consideration that the second phase of the project includes a future expansion to double the size of the free zone area to reach 600 dunums. The project is expected to attract 100 million dinars of different investment activities and provide 3,000 direct and indirect employments.



Joint Use Agreement with RJAF

To fulfill the requirements of all stakeholders and regulate the civil and military use of Amman Civil Airport; JAC has signed a Joint Use Agreement with Royal Jordanian Air Force to apply best practices in managing and operating mixed use airports. The agreement specified the obligations and requirements of each party to ensure smooth air traffic movement and prioritize the activities on a secure, safe and commercial basis.



Emergency Exercise at ACA



Based on the international requirements of the International Civil Aviation Organization (ICAO) and the requirements of the National Program for Civil Aviation Security, Jordan Airports Company conducted an emergency exercise (fire incident at an aircraft on the ground) at Amman Civil Airport on Tuesday, September 3rd 2013, with the participation of all stakeholders.

The purpose of conducting this exercise is to increase the ability of the airport to respond to emergencies related to aircraft accidents and incidents. A comprehensive assessment was conducted to determine the extent of the application of the emergency plan by stakeholders operating at the airport and various supporting organizations from the outside and to make sure to that the operations are sustained at all facilities according to all local and international applicable regulations.
